In Russia, the term "eco-tourism" began to appear in the press in the 1980s. For the first time, specialists from the International Youth Tourism Bureau of the former Soviet Union,

Then in 1997, Gujin G.S. and M.Yu. Belikov and E.V. Klimenok was one of the first in Russia to introduce the definition that "the basis of ecotourism is the protection and preservation of the environment." For that time as well as now, it has been concluded that this definition is the most convenient and represents the true essence of ecotourism⁴.

For the first time in Uzbekistan, the concept of development prospects of the essence, goals and objectives of ecotourism was developed by the State Committee for Nature Protection of Uzbekistan⁵.

In the development of tourism in any country, it is necessary to have the resources and factors of development of tourism, which is inextricably linked. Tourism resources are understood by tourism professionals in different ways. In fact, it means a single economic sector in terms of tourism resources and the content of tourist resources. Only the availability of tourist resources will be the basis for the formation of tourism. That is, tourist resources are the basis of tourism development.
