According to Article 29 of the law, "the decisions taken as a result of corruption offences may be annulled or amended by a competent state body, other organization or official, or deemed invalid in the judicial procedure, according to the application of the person concerned. In the event that it is accepted, changed or found to be invalid as a result of corruption offences committed, the place of damage to individuals and legal entities as a result of its adoption shall be covered in accordance with the procedure established by law." [10] In this regard, in order to ensure the effectiveness of

measures aimed at the Prevention of the corruption system in our country, the decree of the president of the Republic of Uzbekistan "on the organization of the activities of the Anti-Corruption Agency of the Republic of Uzbekistan" [10] was published. The director of this agency was appointed the head of the nationwide movement "Yukselish" Akmal Burkhanov. In articles 210 and 211 of the Criminal Code of the Republic of Uzbekistan, punitive measures for cases of joints with the receipt and bribe is also guilty, along with the person who received the bribe On the basis of the democratic principle of development, our country has reached various agreements with international organizations: in March 2010, it joined the Istanbul Plan for the fight against corruption adopted within the framework of the organization for Economic Cooperation and development (September 10, 2003).
